General

1. Information on how to enter and prize form part of the Terms and Conditions of Entry. Entry into this competition is deemed acceptance of these Terms and Conditions.

2. To the extent of any inconsistency between these Terms and Conditions and any other reference to this competition, these Terms and Conditions prevail.

Who can enter

3. Subject to the clauses below, entry is open to new and existing members of Mingara Recreation Club who have fulfilled the requirements below ('Eligible Entrants'). Entrants must be over 18 as of the date of entry.

4. Employees, and their immediate families, of the Mingara, associated agencies and companies, contractors or individuals are not eligible to enter this competition. Prize
